Thank you for taking the extra time following your lecture at Lily Dale Assembly to speak with me about my son and to look for the underlying cause of his nightmares. You told me that he suffered much trauma during his past lives as a vicious primate and savage warrior. Upon hearing your insight, my soul immediately knew it to be true despite my limited understanding about past lives.

Below, I will share more about his present life to validate your accuracy about how my son's experiences in past lives affect him. Here's an abbreviated list of the ways I can confirm my son's past life experiences as a warrior play out in his life today.

1. Night terrors since he was 6 months old: The subject always involves my son killing people.
2. High sensitivity to noises: As a toddler, my son used to hit the floor and dive under furniture when he would be startled by a noise.
3. Unusual interest in anything related to the military: As a young boy, my son only played with toy soldiers, GI Joe dolls and toy military equipment. Now the only thing he wants to do is become a Navy Seal.
4. Fascinated with the military and history channels: my son has a vast knowledge about wars and facts about military equipment.
5. Slept with a toy weapon since he was 2 years old: my son now sleeps with his hunting knife because he wants to be prepared in case he needs to defend himself if someone breaks in. He started driving a month ago and carries it in his car with him too.
6. Difficult temperament: my son cried often, had a low tolerance for frustration and had temper tantrums as a young toddler and child. Now he gets very anxious and irritable easily. He says he struggles with controlling his anger and feels like hitting people at times.

The most compelling confirmation of your clairvoyance is not in what I've observed in the past but what my son said he is experiencing now. When I told my son all you said about the trauma he experienced in his past lives as a warrior, he was very receptive and felt understood. When I told him what you saw of his past lives, my son immediately told me he almost killed a man the night before. I looked at him strangely as he went on to tell me about a man who parked beside him at the drive-in movie. The man stared at my son the whole movie but gave my son no reason in my opinion to want to harm him.

As I sorted through the information that you gave me and shared it with my husband and son, the most beautiful thing was that my husband was interested too. Even though the concept of past lives is new and unusual to my husband and son they recognized the truth. My husband wants help from you, if possible, understanding his life's purpose. Until now I've been afraid to talk about the subject of reincarnation with my family. I'm excited we can all learn more together.

It is hard to fathom how you came to know my son's circumstances for several reasons: you never met or spoke to him, I told you nothing about him and he was 50 miles away! I am in awe of your gift of clairvoyance. What only took you a few minutes to see and share has begun to heal 19 years of suffering.

I no longer feel like an innocent bystander watching my son suffer endlessly. You gave us hope for a more peaceful life. Please let your daughter know while she waited patiently to go play, her daddy helped my little boy have sweet dreams.
