

CLIENT INFORMATION SHEET FOR PRIVATE SESSIONS WITH CRISTO L. BOWERS

Thank you for purchasing your private session with Cristo L. Bowers. Below you will find information pertaining to your private session and a list of client expectations.

1. Sessions are driven by client interest. Please take time to consider what it is you would like to get out of your session, and prepare your questions beforehand.
2. Cristo takes extensive notes during each session. Notes contain information that pertains to multiple aspects of your energy field. Cristo will scan the notes and send them to you via Dropbox.
3. Sessions are recorded. You will receive a link to your audio file (MP3 or WAV format) via Dropbox within 72 hours that you can then download for free.
 - a. Cristo does his best to record an audio image of the session. However, periodically there are technical difficulties that prevent this from happening. Thus, a recording of your session cannot be guaranteed. If you so desire, you may use your own auxiliary recording device to record the session.
4. While clients do find the sessions themselves to be transformative, the greatest growth and healing comes from repeatedly engaging the audio file subsequent to the initial session. You will be expected to listen to the audio file a minimum of five to seven times prior to your scheduled follow-up session(s), if your purchase includes a follow-up session(s).
 - a. Follow-up sessions are not intended to be independent sessions. They are meant to review material from the initial session and to answer questions that arise from listening to the audio file of the initial session.
 - b. If you have multiple follow-up sessions, it is your responsibility to ensure your additional follow-up time is scheduled.
5. Over the course of listening to your audio file, if you develop any pressing questions, please feel free to contact Cristo. The time used during the phone call will be deducted from the balance of time reserved for your follow-up session(s).
6. Sessions are conducted by telephone. For clients outside of the United States, sessions are conducted via Skype. Sessions can also be conducted in person at Cristo's home office in Pinckney, Michigan.
7. If you need to reschedule your session, please contact Diane as soon as possible at (734) 878-3198. If you need to reschedule your session the day of your session, please contact Cristo at (734) 478-5696.
8. Occasionally, Cristo needs to reschedule a session due to work, travel or family emergencies. If this occurs, Cristo will fit you into his schedule as soon as possible.
9. In the event you cancel your session with advance notice, you will be given the first available session on his calendar. New sessions are generally scheduled 3+ months in advance.
9. In the event you miss a scheduled session without notice, it is within Cristo's discretion whether to grant you a replacement session or consider his session with you complete.
10. All payments made to Cristo L. Bowers, his companies, or to agents acting on his behalf are non-refundable or refundable at the sole discretion of Cristo L. Bowers. In certain cases, at the sole discretion of Cristo L. Bowers, unused portions of time may be transferable. The amount of time that is transferable is determined by Cristo L. Bowers.
